2. **Substitution of O.198-H on page No. 188 of H.B. pt. II 1984 subsequently amended vide Pamphlet No. 1, Pamphlet No. 4 and Pamphlet No. 8 .**

O. 198-H has been substituted to read as under :

(S.R. No. 2 (4) of 18-12-93 and S.R. No. 28 of 27-1-94).

When the Selection Committee has not been able to recommend sufficient number of candidate/s for the post of Professor, Reader, Lecturer, Senior Instructor or a Temporary Leave vacancy occurs in these posts and there is a need to make some arrangement immediately for teaching, the Vice-Chancellor shall have power to make appointments of the persons as "Temporary Lecturer" against the vacant post of Professor, Reader, Lecturer or Senior Instructors who fulfills the required qualifications with good academic records as per G.R. No. MIS/1189/5213/KH dated 12.2.90 as amended from time to time by the Government for a period not exceeding one year. The Temporary Lecturer receive the minimum pay of the scale of Lecturer. Such appointment shall be made by giving advertisement in Local News paper and be reported to the Syndicate.

Notwithstanding anything contained in O.198-H the Vice-Chancellor is authorised to consider the appointment of Teaching Assistant incase where qualified Temporary Lecturers are not available. The Teaching Assistant to be appointed must meet the Educational Qualification and exception be made only in terms of requisite years of experience for the post.

The remuneration of the Teaching Assistant shall be Rs. 2500/- p.m. net and shall be effective from 1-12-1993.

3. **Amendment in Clause Nos. 1 and 5 and substitution of Clause 12 of Enclosure A (Service Agreement Form) of O.200 (1) (i) (b) on page No. 197 of H.B. pt. II-1984 (S.R. No. 2 (6) of 27-1-94).**

Clause Nos. 1 and 5 of Enclosure A (Service Agreement Form) of O.200 (1) (i) (b) has been amended to read as under :

Clause 1.

That the said (1) _____ shall abide by the conditions of service such as Leave Rules, Pension Scheme, Discipline and Conduct Rules as may be laid down from time to time.

Clause 5

That, during the continuance of his service under the terms of the agreement, the said (1) _____ shall be entitled to the benefit to the Pension Scheme as constituted by Section 54 of the said Act and the Statutes made thereunder and shall pay to the General Provident Fund such subscriptions as shall be payable under the said Statutes (by which Statutes he agrees to be bound) and that the University may deduct the said subscriptions from any money that may be payable to the said (1) _____ under this agreement or otherwise.

Clause No. 12 of Enclosure A (Service Agreement Form) of O.200 (1) (i) (b) has been substituted to read as under :

Clause -12

Where there is any dispute between the University and any University employee which is connected with the conditions of service of such University employee, the University or as the case may be the University employee may take action, if they deem fit as per the provision of Section 8 of the Gujarat Universities Services Tribunal Act, 1983.
