O. 209 (7) (a) - International leave :

So far as International conference/seminar and other engagement are concerned such leave can be granted up to the period of 30 days by the Vice-Chancellor, if the T.A., D.A. etc. are not to be borne by the University or are to be borne from the University Grants Commission unassigned grant subject to conditions as mentioned in the foregoing paras. Beyond 30 days such leave will be granted by the Syndicate depending upon norms prescribed above.
